## **General Business**

Director's seminar

Amount of honorarium for Chair and Secretary of ANRC needs to be raised, to be addresses at next National Conference

Regional conference, when, why and in what form, Potential speakers; Karen Martelletti, Jane Spears and Claire Coles.

Neil Beckett believes the ANRC website is dull. It needs to be personalized, ie photos of events. Could also be a potential platform, allowing topical issues to be discussed at a distance, replacing the need for the regional conference?

The website is under utilized

Date for next regional conference to be determined at next meeting

Chair to research Constitutional changes and the Proxy system before the next AGM

Two remits going forwards to the Bridge AGM from Regions. Also reported, NZ Bridge are doing a full constitutional review which would result in further remits to the AGM

Power to veto board appointments changed

Maximum of a nine year term for board members dropped

Remits can now be lodged directly by clubs, discussion ensued

A/NRC Chair did not receive an Agenda for the National AGM, after checking incoming correspondence, it was found not to have been sent. Chair gives a verbal account at the AGM

Funding of Development Officers discussed, Chair suggested ANRC happy to subsidize to a certain extent

Neil asked what NZ Bridge's contribution will be, there is need to be transparent

It was decided that ANRC would give its feedback to the board initiative after it had received all the feedback from clubs in its region.

Should we have a Directors seminar before October, as the last one was cancelled in June?

Trevor recommended that local Directors be asked first, in future to run any such events

Neil would like the Master points funding by NZ Bridge to be addressed

Can the ANRC ask NZ Bridge to notify all clubs of constitutional changes and remits being voted on, so clubs have time to discuss
